## Extrajudicial Killings:

Sistan and Baluchistan has recently seen a growing number of extrajudicial killings of ordinary citizens by Iranian security forces. The security forces are supposed to safeguard the lives of citizens and ensure their livelihoods, but quite the opposite is happening, not only are they not safeguarding lives but they have gone on a killing spree without any accountability.

The extrajudicial killings of so called "fuel smugglers" by Iranian security forces has increased alarmingly. Lack of employment opportunities and worsening economic conditions in Iran as a whole and Baluchistan in particular has forced the local population to resort to risky and dangerous jobs such as cross boarder transportation of fuel and other everyday items between neighboring Pakistani province of Baluchistan. Unfortunately a high number of them, mostly young, are targeted by Iran's Islamic Revolutionary Guards Corps (IRGC) and are shot dead in the most inhuman and brutal ways. Many of the victims bodies are left to turn to ash inside their burning cars. This has made the roads unsafe and dangerous even for citizens going about their daily lives who need to use these so called death roads.

Below are the details of those that have been killed during last 3 months:

- 1- Mossa Shabbakhsh - shot dead in Zahedan on May 25, 2019.
- 2- Ali Reza Koseh - killed, was from Dashtyari in Chabahar on May 20, 2019.
- 3- Arash Bameri - 14 years old from Bampur killed and his father Amir had been severely injured on May 17, 2019
- 4- Mohammad Malek Raissi - from Iranshahr killed on May 15, 2019.
- 5- Adham Charizahi - from Magas in Saravan killed on May 13, 2019.
- 6- Piral Ziorkabadi - from Nickshahr killed on May 12, 2019.
- 7- Rahim Chandokani - from Nickshahr killed on May 12, 2019.
- 8- Mohammad Havaz Zarozaei - from Saravan killed on May 10, 2019.
- 9- Ali Reza Bameri - 11 years old from Dalgan in Iranshahr killed on May 9, 2019.
- 10- Rahman Bameri - 22 years old from Dalgan in Iranshahr killed on May 9, 2019.
- 11- Omid Bameri - 23 years old from Dalgan in Iranshahr killed on May 9, 2019.
- 12- Ehsan moradi - 32 years old from Minab killed on May 3, 2019.
- 13- Navab Naroui - died under torture from Saravan on May 1, 2019.
- 14- Henayat Fazali son of Faghir Mohammad - killed by Jalgh military forces on 2<sup>nd</sup> April
- 15- Rasoul Notizahi - killed by Khash military force on Feb 26, 2019.

## Arbitrary Detention:

Iran has been violating the Principles for the Protection of All People under any Form of Detention or Imprisonment, the Declaration on the Protection of All People from Enforced Disappearance and the Principles on the Effective Prevention and Investigation of Extra-legal, Arbitrary and Summary Executions.

Article 32 of the Iranian Constitution states explicitly that arresting an individual if it is a necessity should be done in accordance to the procedures which are enshrined in the law. If someone is detained, the subject matter of the charge, with an explanation why, must immediately be communicated and explained in writing to the accused. Within at most 24 hours the file on the case and preliminary documentation must be sent to the competent legal authority. Legal procedures must be initiated as early as possible. Anyone infringing this principle should be punished in accordance with the law.

In contradiction with national law in Iran minorities in Iran face arbitrary arrests, along with extrajudicial killings. These types of arrests and intimidation of minorities did not decrease since the last UPR cycle in 2018, but has been increasing steadily.

So far in 2019, at least 50 more people were arrested on various malicious grounds by the Iranian regime.

7. Hamidullah Arbabi - 25 years old from Nickshahr was arrested months ago and until now there is no news about his whereabouts.

## Execution:

There is no respite in executions of Baluch citizens in Iran. After achieving the infamous second position in execution of its citizens in 2018, it seems that Iran is in a hurry to get the record for first place this year. The highest number the executions in Iran belongs to religious and ethnic minorities. 20% of total executions in Iran last year were Baluch citizens, though they only constitute about 5 - 7% of the total population in Iran. Baluch prisoners are taken as hostages by The Iranian regime which they then go on to hanging one by one or even sometime in groups in complete media blackout. The following are the details of the latest people who have been executed in Iranian prisons.

1. Mohammad Bameri - 24 years old student were executed in Kerman. He was in jail for 5 years and executed on April 24 2019.
2. Kamal Shahbakhsh - was in jail for 6 years. He was executed on April 24 2019.
3. Abdullah Qanbarzahi - 29 years old was executed in Isfahan prison on March 27 2019.
4. Henayatullah Totazahi, Son of Abdul Samad - 25 years old. He was in Zahedan jail since 7 years and was executed on March 16 2019.
5. Shirmohammad Narouie - 50 years old, was executed in Birjand prison on March 11 2019.
6. Younes Narouie - 20 years old, was executed in Brigand prison on March 11 2019.
